

CITY OF SURREY
BY-LAW NO. 15554

A by-law to amend the provisions of the “Capital Works Reserve Fund for the Provision of Facilities and Amenities within Neighbourhood Concept Plan Areas Reserve Fund Expenditure Authorization By-law, 2003, No. [15191](#).”

1. “Capital Works Reserve Fund for the Provision of Facilities and Amenities within Neighbourhood Concept Plan Areas Reserve Fund Expenditure Authorization By-law, 2003, No. 15191” is hereby amended as follows:

(a) Delete section 1. in its entirety and replace it as follows:

The sum of One Million Three Hundred Eighty Thousand Dollars (\$1,380,000) is hereby appropriated from the Capital Works Reserve Fund for the Provision of Facilities and Amenities within Neighbourhood Concept Plan Areas, specifically for:

- a) North Cloverdale West, Library Services, in the sum of Ten Thousand Dollars (\$10,000),
- b) East Newton North, Library Services, in the sum of Twenty Thousand Dollars (\$20,000),
- c) East Newton North, Police Services, in the sum of Fifty Thousand Dollars (\$50,000),
- d) East Newton North, Park Development, in the sum of Eighty Thousand Dollars (\$80,000),
- e) East Newton South, Library Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- f) East Newton South, Police Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- g) East Newton South, Park Development, in the sum of One Hundred Seventy Thousand Dollars (\$170,000),
- h) East Clayton, Library Services, in the sum of Forty Thousand Dollars (\$40,000),
- i) East Clayton, Park Development, in the sum of One Hundred Sixty Five Thousand Dollars (\$165,000),
- j) West Cloverdale North, Library Services, in the sum of Forty-five Thousand Dollars (\$45,000),
- k) West Cloverdale North, Fire Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- l) West Cloverdale North, Park Development, in the sum of Seventy Thousand Dollars (\$70,000),
- m) West Newton North, Library Services, in the sum of Fifteen Thousand Dollars (\$15,000),

- n) West Newton North, Park Development, in the sum of One Hundred Twenty Thousand Dollars (\$120,000),
- o) West Newton South, Library Services, in the sum of Ten Thousand Dollars (\$10,000),
- p) West Newton South, Park Development, in the sum of Sixty Thousand Dollars (\$60,000),
- q) Rosemary Heights West, Library Services, in the sum of Fifteen Thousand Dollars (\$15,000),
- r) Rosemary Heights West, Park Development, in the sum of Twenty Thousand Dollars (\$20,000),
- s) Rosemary Heights Central, Library Services, in the sum of Thirty-five Thousand Dollars (\$35,000),
- t) Rosemary Heights Central, Fire Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- u) Rosemary Heights Central, Park Development, in the sum of One Hundred Fifty Thousand Dollars (\$150,000),
- v) South Newton, Fire Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- w) South Newton, Park Development, in the sum of Fifty-five Thousand Dollars (\$55,000),
- x) Fleetwood Town Centre, Library Services, in the sum of Fifteen Thousand Dollars (\$15,000),
- y) Fleetwood Town Centre, Fire Services, in the sum of Twenty-five Thousand Dollars (\$25,000),
- z) Fleetwood Town Centre, Park Development, in the sum of Seventy-five Thousand Dollars (\$75,000), and
- aa) North Grandview Heights, Library Services, in the sum of Ten Thousand Dollars (\$10,000).

To be expended for the following purpose for the Year 2004:

Fire Services Capital Improvements	100,000

2. Should any of the above amounts remain unexpended after the expenditure hereby authorized has been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.

3. This by-law shall be cited for all purposes as “Capital Works Reserve Fund for the Provision of Facilities and Amenities within Neighbourhood Concept Plan Areas Reserve Fund Expenditure Authorization By-law, 2003, No. 15191, Amendment By-law, 2004, No. 15554”.
