

CITY OF SURREY

BY-LAW NO. 16105

A By-law to provide for the exemption from taxation of certain properties in the City of Surrey pursuant to Section 224 of the "*Community Charter*"

.....

WHEREAS Council may, by authority of Section 224 of the *Community Charter*, S.B.C. 2003, Chap. 26, exempt from taxation certain properties;

AND WHEREAS Council deems it expedient to exempt from taxation the properties listed in Schedule A attached hereto.

NOW, THEREFORE, Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

Title

1. This By-law may be cited as the "Section 224 Tax Exemption By-law, 2006, No. 16105".

Exemptions

2. The lands or improvements, or portions thereof, as outlined in Schedule "A" attached hereto, are hereby exempt from taxation for the Year 2007 pursuant to Sections 224 of the *Community Charter*, S.B.C. 2003, Chap. 26.
3. The lands or improvements, or portions thereof, as outlined in Schedule "B" are hereby exempted from taxation for the Year 2007 in the City of Surrey pursuant to Section 224 of the *Community Charter*, S.B.C. 2003, Chap.26.
4. A proportionate amount of the lands or improvements, as shown on Schedule "C" attached to this by-law are hereby exempted from taxation for the Year 2007 in the City of Surrey pursuant to Sections 224 of the *Community Charter*, S.B.C. 2003, Chap.26.

Repeal Section

5. "Tax Exemption By-law, 2005, No. 15836" is hereby repealed.
