WHEREAS pursuant to Section 99 of the *Local Government Act*, R.S.B.C. 1996, Chapter 323, as amended, the Council of the City of Surrey, may, by by-law:

- establish one or more special voting opportunities for the local government election;
- establish restrictions on persons who may vote at the special voting opportunities; and
- establish, or authorize the chief election officer to establish the date and voting hours when and the place where the special voting opportunities are to be conducted;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

SPECIAL VOTING OPPORTUNITIES

1. Special voting opportunities are hereby established at the following places only for the residents or patients of the facilities named below who would otherwise be unable to vote:

PROCEDURES

2. These special voting opportunities shall provide for bedside voting and the presiding election official shall proceed to each room to determine which patients are eligible and wish to vote. The Special Voting Opportunities will also provide for voting for residents of the facilities. Upon determining the eligibility of the elector, the presiding election official shall proceed in accordance with the provisions of "Automated Vote Counting System Authorization and Procedure By-law, 1996, No. 12858."

DATE AND VOTING HOURS

3. The chief election officer is hereby authorized to establish both the date and voting hours when voting at each of the special voting opportunities specified in this by-law shall be conducted.

REPEAL

4. "Special Voting Opportunities Establishment By-law, 2005, No. 15754" is hereby repealed.

CITATION

5. This By-law shall be cited for all purposes as "Special Voting Opportunities Establishment By-law, 2008, No. 16687."
