BY-LAW NO. 17310

A by-law to amend the provisions of
"Business License By-law, 1999, No. 13680," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1. "Business License By-law, 1999, No. 13680," as amended is hereby further amended as follows:
 - 1) Section 2, Interpretation, is amended by deleting the following paragraph: "*Secondary Suite*" means an additional dwelling unit, located in the structure of an owner-occupied single family dwelling."
 - 2) Section 59 is amended by deleting it in its entirety.
 - 3) Schedule "A" is amended by deleting it in its entirety and replaced with "Schedule "A"" as follows:
