A by-law to amend the provisions of "Surrey Subdivision and Development By-law, 1986, No. 8830," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1. "Surrey Subdivision and Development By-law, 1986, No. 8830," as amended is hereby further amended as follows:
 - (1) Schedule B is amended by deleting it in its entirety and inserting a new Schedule B, attached hereto and forming part of this by-law.
2. This By-law shall be cited for all purposes as "Surrey Subdivision and Development By-law, 1986, No. 8830, Amendment By-law, 2010, No. 17326".

SCHEDULE "B"
TO SURREY SUBDIVISION AND DEVELOPMENT BY-LAW NO. 8830
SERVICING AGREEMENT PROCESSING, ENGINEERING ADMINISTRATION AND
FINANCIAL ADMINISTRATION FEES

1. SERVICING AGREEMENT PROCESSING FEE (payable prior to the project scoping submission)

Pre-Application Engineering Review

- Fixed Fee \$895.00

Mini Agreements (Utility Connections with Development)

- Fixed Fee \$2,455.00

Residential

Servicing Agreement for Single Family Developments with subdivision or building permit.

2 - 20 units - \$1,090.00/unit - \$4,915.00 min., \$17,035.00 max.

21 - 50 units - \$810.00/unit - \$33,945.00 max.

51 - 100 units - \$665.00/unit - \$55,650.00 max.

Over 100 units - \$60,085.00 fixed fee

Servicing Agreement for Multi-family Developments with subdivision or building permit.

2 - 20 units - \$500.00/unit - \$4,915 min., \$8,520.00 max.

21 - 50 units - \$405.00/unit - \$16,975.00 max.

51 - 100 units - \$335.00/unit - \$27,600.00 max.

Over 100 units - \$29,800.00 fixed fee

Commercial and Industrial

\$190.00/1,000 sq.m. of site or part thereof with a minimum fee of \$4,915.00

Short Form Servicing Agreements, an additional fee of \$1,090.00

Agricultural:

\$100.00/1,000 sq.m. of site or part thereof with a minimum fee of \$4,915.00

Other

\$100.00/1,000 sq.m. of site or part thereof with a minimum fee of \$4,915.00

Note: In the case of comprehensive developments involving more than one use, the above fees can be combined to arrive at the total fee.

Administrative Processing Only

\$1,090.00 for applications involving only the processing of legal documents and/or utility capacity calculations.

\$520 for Processing Continuance (for each year project continues beyond Year 1)

\$285 for Service Agreement Extension or Reassignment

2. ENGINEERING ADMINISTRATION FEE (applicable only in case project proceeds to construction stage.)

Single Family Developments

4.0% on the first \$250,000.00 of estimated construction cost

2.5% on the next \$250,000.00 of estimated construction cost

1.5% on the remaining estimated construction cost

as approved by the General Manager, Engineering

Agricultural, Multi-family, Institutional, Commercial and Industrial Developments

5.25% on the first \$250,000.00 of estimated construction cost

4.25% on the next \$250,000.00 of estimated construction cost

3.0% on the remaining estimated construction cost

as approved by the General Manager, Engineering

3. FINANCIAL ADMINISTRATION FEE

Each Latecomer Agreement - \$1,435.00

Each DCC Front Ender and Development Works Agreements - \$4,635.00

Latecomer, DCC Front Ender or Development Works Agreement Reassignment - \$285.00

All fees are subject to applicable taxes.
