PASSED THIRD READING on the 18th day of April, 2011.

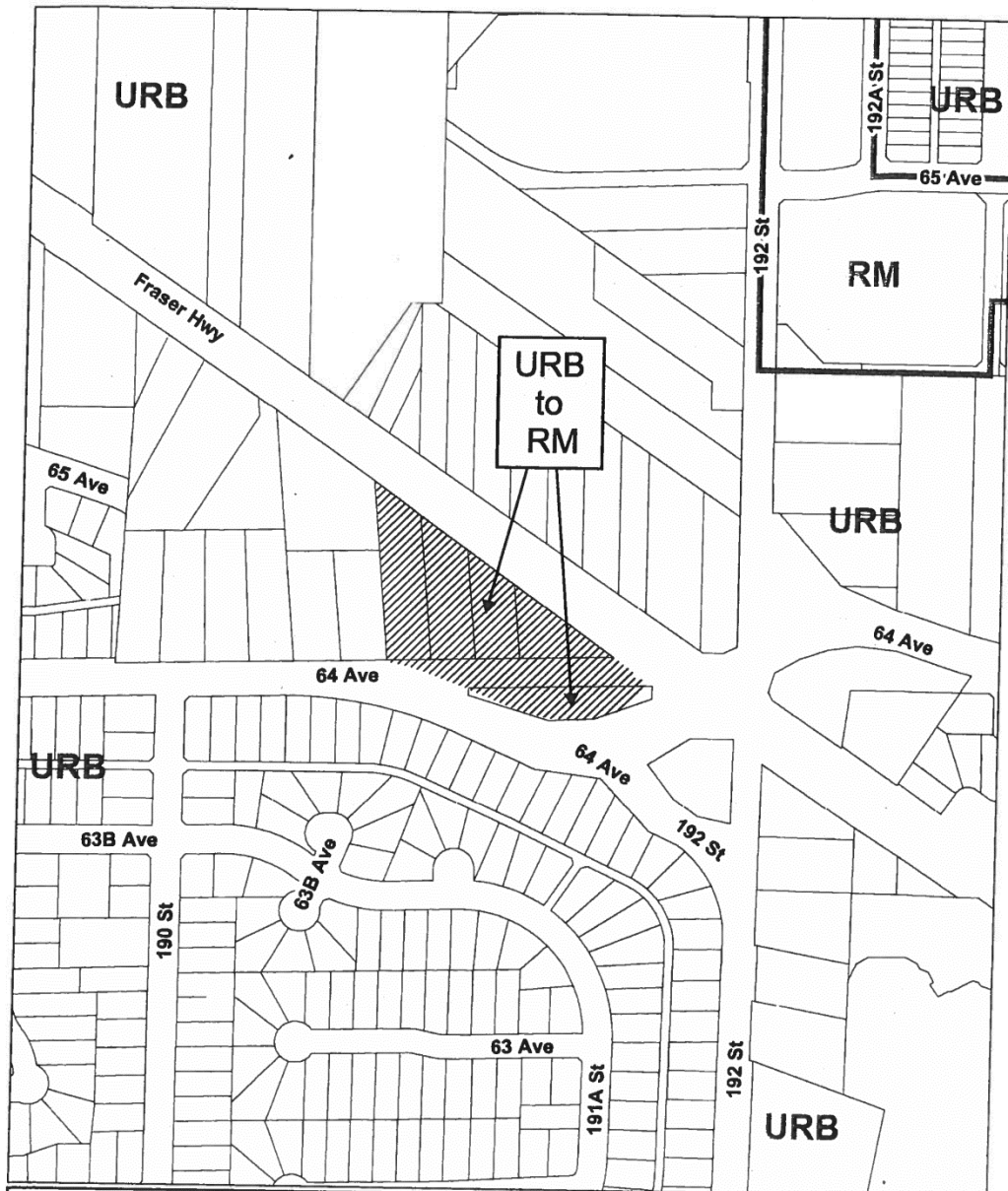
