

CITY OF SURREY

BY-LAW NO. 17913

A by-law to provide for the levying of rates for  
general city purposes and special services for the  
Year 2013 in the City of Surrey.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. The following rates are hereby imposed and levied for the Year 2013:
  - (a) For the purpose of providing for all lawful general purposes of the City, including due provision for uncollectible taxes and for taxes that it is estimated will not be collected during the year, there is hereby imposed and levied upon the assessed value of land and improvements taxable for general City purposes according to the last revised assessment roll of the City, rates appearing in Column A of Schedule "A" attached hereto and made part of this by-law.  
  
"Improvements" for the purpose of levying rates for general City purposes means improvements as defined for that purpose in the "Assessment Act."
  - (b) For the purpose of providing for the drainage system as authorized by "Pacific Highway Hall's Prairie Road Drainage Area Establishment Construction and Loan By-law, 1967, No. 2593," together with the costs of maintenance and operation thereof, there is hereby imposed and levied upon the assessed value of the land for general City purposes according to the last revised assessment roll of the City, in that portion of the City described in the said by-law, rates appearing in Column B of Schedule "A" attached hereto and made part of this by-law.
2. The taxes shall be payable to the Collector of the City of Surrey at the City Hall, Surrey, B.C.


3. This By-law shall be cited for all purposes as "Surrey General Rates Levy By-law, 2013, No. 17913."


PASSED FIRST READING on the 22nd day of April, 2013.
