BYLAW NO. 18006

A bylaw to amend "Surrey Zoning By-law, 1993, No. 12000," as amended.

The Council of the City of Surrey ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1993, No. 12000", as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of "Surrey Zoning By-law, 1993, No. 12000", as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)  
TO: MULTIPLE RESIDENTIAL 30 ZONE (RM-30)

Shown on a Survey Plan attached hereto and forming part of this Bylaw as Schedule A, certified correct by G. A Rowbotham, B.C.L.S. on the 3rd day of July 2013, containing 0.745ha called Block A and more particularly described as follows:


PASSED FIRST READING on the 8th day of July, 2013.


PASSED SECOND READING on the 8th day of July, 2013.
