

CITY OF SURREY
BYLAW NO. 18138

A bylaw to amend the provisions of "Surrey Tree Protection Bylaw, 2006, No. 16100," as amended.

The Council of the City of Surrey ENACTS AS FOLLOWS:

1. "Surrey Tree Protection Bylaw, 2006, No. 16100," as amended is hereby further amended as follows:

(a) Section 36 is amended by replacing the "SIXTY-SEVEN (\$67.00) DOLLAR base fee plus TWENTY-SIX (\$26.00) DOLLARS" with "SIXTY-NINE (\$69.00) DOLLAR base fee plus TWENTY-SEVEN (\$27.00) DOLLARS".

(b) Section 37 is amended by deleting the Zone and Lot Size table and replacing it with the following Zone and Lot Size table:

- (e) Section 40 is amended by replacing the "SEVENTY-THREE (\$73.00) DOLLARS" amount with "SEVENTY-FIVE (\$75.00) DOLLARS".


- (f) Section 71 is amended by replacing the "NINETY-ONE (\$91.00) DOLLARS" amount with "NINETY-FOUR (\$94.00) DOLLARS".


PASSED FIRST READING on the 16th day of December, 2013.
