A bylaw to amend the provisions of "Highway and Traffic
By-law, 1997, No. 13007," as amended.

The Council of the City of Surrey ENACTS AS FOLLOWS:

1. "Highway and Traffic By-law, 1997, No. 13007," as amended, is hereby further amended as follows:
 - (1) Schedule B is deleted in its entirety and replaced with a new Schedule B, attached hereto and forming part of this bylaw.


2. This Bylaw shall be cited for all purposes as "Highway and Traffic Bylaw, 1997, No. 13007, Amendment Bylaw, 2015, No. 18586".

SCHEDULE OF FEES**

City Road and Right-of-Way Use Permit

- General: \$ 58.00
- Servicing Agreement: \$ 87.00
- Inspection^{1,2}: \$ 99.00
- Video inspection^{1,2}: \$ 208.00
- Shoring and hoarding: \$ 351.00

Traffic Obstruction Permit

- General: \$ 58.00
- Servicing Agreement: \$ 87.00
- Road Closure: \$ 177.00
- Traffic Control Training: \$ 175.00

Oversize Permit

- Single trip: \$ 58.00
- Book of 10: \$ 524.00
- Annual permit (up to 3.20 m wide): \$ 291.00
- Annual permit (> 3.20 m & up to 3.80 m wide): \$ 582.00

Overload Permit

- Single trip: \$ 58.00
- Annual permit: \$ 291.00

Pavement Cut

- < 50 m²: \$ 85.00/m²
- > 50 m²: \$ 75.00/m²
- Minimum charge: \$ 520.00
- Pavement degradation fee (\$10.00/m²): Included

All Land Development Works:

Fees collected at execution of Servicing or Mini-Servicing Agreement

Capital Works Projects:

Fees included as part of contract

Site Specific Municipal Access Agreement

- Works per site < 20 m: \$ 1,634.00
- Works per site ≥ 20 m: \$ 1,634.00 plus \$10.00/m
