BYLAW NO. 18592

A bylaw to amend the provisions of "Surrey Tree Protection By-law, 2006, No. 16100," as amended.

The Council of the City of Surrey ENACTS AS FOLLOWS:

1. "Surrey Tree Protection By-law, 2006, No. 16100," as amended is hereby further amended as follows:

a. Section 36 is amended by replacing the "SEVENTY THREE (\$73.00) DOLLAR base fee plus TWENTY-NINE (\$29.00) DOLLARS for every protected tree remove" with "SEVENTY-SIX (\$76.00) DOLLAR base fee plus THIRTY (\$30.00) DOLLARS for every protected tree removed".

b. Section 37 is amended by deleting the Zone and Lot Size table and replacing it with the following Zone and Lot Size table:

- d. Section 39 is amended by deleting the Zone Designation table and replacing it with the following Zone Designation table:

A-1, A-2, A-3 within the ALR	\$371 per acre	\$335 per acre	\$294 per acre

- e. Section 40 is amended by replacing the "SEVENTY-NINE (\$79.00) DOLLARS" amount with "EIGHTY-TWO (\$82.00) DOLLARS".


