The Council of the City of Surrey ENACT AS FOLLOWS:


1. "Surrey Animal Responsibility Bylaw, 2017, No. 19105" is hereby amended as follows:
 - (a) Schedule "B" is deleted in its entirety and replaced with a new Schedule "B", attached hereto and forming part of this bylaw.
 - (b) Schedule "C" is deleted in its entirety and replaced with a new Schedule "C", attached hereto and forming part of this bylaw.
 - (c) This Bylaw shall be cited for all purposes as "Surrey Animal Responsibility Bylaw, 2017, No. 19105, Amendment Bylaw, 2017, No. 19420".

PASSED FIRST READING on the 4th day of December, 2017.


PASSED SECOND READING on the 4th day of December, 2017.

Schedule "B"

LICENCING:

Dogs

- 1) Neutered male or Spayed female \$45.00
- 2) Other than (1) above \$73.00
- 3) Guard Dog/Aggressive Dog \$137.00
- 4) Vicious Dog \$208.00
- 5) Dangerous Dog \$520.00
- 6) Guide Dog/Service Dog \$0.00
- 7) Police Services Dog \$0.00
- 8) New licences issued from August 31 to December 31 of any given year shall be subject to a fee equal to 50% of the above noted fees. This does not apply to renewals, Guard, Aggressive, Vicious or Dangerous Dogs or to Dogs eligible to be licensed prior to August 31.
- 9) Persons over the age of 65 shall be subject to a fee equal to 50% of the above noted fees.

DOGS

- 1) Unlicensed \$112.25
- 2) Licensed
 - a. Spayed or Neutered \$33.50
 - b. Not Spayed or Neutered \$49.25
 - c. Aggressive or Guard Dog \$312.00
 - d. Vicious Dog \$520.00
 - e. Dangerous Dog \$1040.00
 - f. A Dog where it has caused injury while Running at Large \$1040.00
 - g. Dangerous Dog where it has caused injury while Running at Large \$5198.00

CATS AND OTHER SMALL ANIMALS

- 1) Cats
 - a. Spayed or Neutered \$10.50
 - b. Not Spayed or Neutered \$52.00
- 2) Other Small Domestic Animals \$10.50

LIVESTOCK

- 1) Stallion or bull \$520.00
- 2) Horse or cows \$208.00
- 3) Goat or sheep \$52.00
- 4) Rabbit, goose, chicken or other fowl \$10.50
- 5) In addition to these fees the Owner(s) of the Animal(s) shall be liable for any hauling fees incurred by the Animal Shelter Manager and any other extraordinary costs, due and payable upon reclamation.

ADOPTION OF ANIMALS

- 1) Puppy (up to and including 1 year of age) \$260.00
- 2) Dog (over 1 year up to and including 7 years of age) \$208.00 (plus license fee if applicable)
- 3) Dog (over 8 years of age) \$83.00 (plus license fee if applicable)
- 4) Cat (up to and including 7 years of age) \$156.00
- 5) Cat (over 8 years) \$83.00
- 6) Small Animals \$5.00-\$41.50

BOARDING OF ANIMALS:

- 1) Rate per Day
- 2) Cat \$6.75
- 3) Dog \$16.75
- 4) Stallion, horse, mule, ass, boar, billy goat, ram, goat, sheep, swine, bull, cow or other bovine
Animal \$15.50
- 5) For each rabbit, goose, chicken or other fowl \$5.25
- 6) For Animals other than those listed above \$10.50

EUTHANASIA

- 1) 0 - 20 lbs \$104.00
- 2) 21 - 50 lbs \$156.00
- 3) 51 - 100+ lbs \$208.00

CREMATION SERVICES

General Cremations - no ashes returned

- 1) 0 - 20 lbs \$52.00
- 2) 21 - 50 lbs \$78.00
- 3) 51 - 75 lbs \$104.00
- 4) 76 - 100 lbs \$130.00
- 5) 101 + lbs \$156.00

Animal Pick Up Fee \$52.00 per pick up
