

CITY OF SURREY

BYLAW NO. 19428

A bylaw to amend the provisions of "Surrey Sign By-law, 1999, No. 13656.", as amended.
.....

The Council of the City of Surrey ENACTS AS FOLLOWS:

1. "Surrey Sign By-law, 1999, No. 13656.", as amended is hereby further amended as follows:
 - (a) Part 1, Introduction Provisions, Exemption is amended as follows:
 - i. Section 7, sub-section (12) is deleted in its entirety and replaced with the following:

"(12) *Window sign* up to a maximum of three *window signs* per premises provided that:

 - (a) the *sign area* of each window shall not exceed the larger of a maximum of 0.3 sq. m. (3 sq. ft.) or 25% of the area of the window; and
 - (b) if the *signs* are located on a *lot* in a Commercial or Industrial Zone, the total *sign area* of all *window signs* shall comply with the combined *sign area* provisions Section 27(2)(b)."
 - (b) Part 2, General Provisions – Sign Permits is amended as follows:
 - i. Section 13, sub-section (1)(a) is amended by deleting the words "of \$73.00" and replacing it with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
 - ii. Section 13, sub-section (1)(b) is deleted in its entirety and replaced with the following:

"(b) The permit fee in accordance to "Surrey Fee-Setting By-law, 2001, No. 14577" will be assessed for all new *signs* based on total *sign area*. For multi-faced *signs* and for L-shaped or angularly connected *signs* considered as two *signs* pursuant to this Bylaw, the total *sign area* shall be the aggregate of *sign area* on all faces."
 - iii. Section 13, sub-section (1)(c) is amended by deleting the words "of \$149.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
 - iv. Section 13, sub-section (1)(e) is amended by deleting the words "of \$500.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".


- v. Section 16, subsection (1) is amended by deleting the words "of not less than \$100.00 and not more than \$2,000.00 for each offense" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
- (c) Part 4, Signs in Residential Zones is amended as follows:
- i. Section 23, sub-section (5)(e) is amended by deleting the words "of \$500.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
 - ii. Section 23, subsection (5)(f) is amended by deleting the words "of \$215.00" and "of \$108.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
- (d) Part 5, Signs In Commercial/Industrial Zones is amended as follows:
- i. Section 27, sub-section (9)(f) is amended by deleting the words "of \$500.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
 - ii. Section 27, subsection (9)(g) is amended by deleting the words "of \$215.00" and "of \$108.00" and replacing them with the words "in accordance to *Surrey Fee-Setting By-law, 2001, No. 14577*".
2. This Bylaw shall be cited for all purposes as "Surrey Sign Bylaw, 1999 No. 13656, Amendment Bylaw, 2017, No. 19428".


