BYLAW NO. 19440

A Bylaw to authorize the Termination of
Land Use Contract Number 290.

.....

WHEREAS on the 21st day of June 1977, this City entered into a Land Use Contract with Abacus Cities Ltd., for the use and development of the lands therein described;

AND WHEREAS the Council deems it expedient that the rights and obligations created and to be performed under the said Land Use Contract should terminate and be no longer of force or effect;

AND WHEREAS Section 548.2 and 464.1 (c) of the *Local Government Act*, R.S.B.C. 2015, c.1, as amended, provides that a Land Use Contract may only be terminated by bylaw and only after a Public Hearing.

NOW, THEREFORE, the Council of the City of Surrey enacts as follows:

4. This Bylaw may be cited for all purposes as "Surrey Land Use Contract No. 290, Termination Bylaw, 2017, No. 19440".




