SUBJECT: **Award of Contract No. 1718-002-11  
2018 Collector Road Package**

## RECOMMENDATION

The Engineering Department recommends that Council:

1. Award Contract No. 1718-002-11 to Lafarge Canada Inc. in the amount of \$3,984,849.75, (including GST), for the 2018 Collector Road Package;
2. Set the expenditure authorization limit for Contract No. 1718-002-11 at \$4,343,000.00, (including GST and contingency); and
3. Authorize the General Manager, Engineering to execute Contract No. 1718-002-11.

## SCOPE OF WORK

The construction package related to this Contract consists of collector road and arterial road paving at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The Contract work is expected to start on June 18, 2018, and be completed by November 02, 2018.

## TENDER RESULTS

The Tenders for the subject Contract were opened on May 10, 2018 with the following results:

The Engineer's (Web Engineering Ltd.) pre-tender estimate was \$4,575,000.00 (including GST).

## EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Lafarge, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 100 working days, as stipulated in the Contract. Lafarge's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Lafarge be awarded Contract No. 1718-002-11.

## SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, this work relates to the Sustainability Charter 2.0 theme Infrastructure. Specifically, this Contract supports the following Strategic Directions (SD) and Desired Outcomes (DO):

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems; and

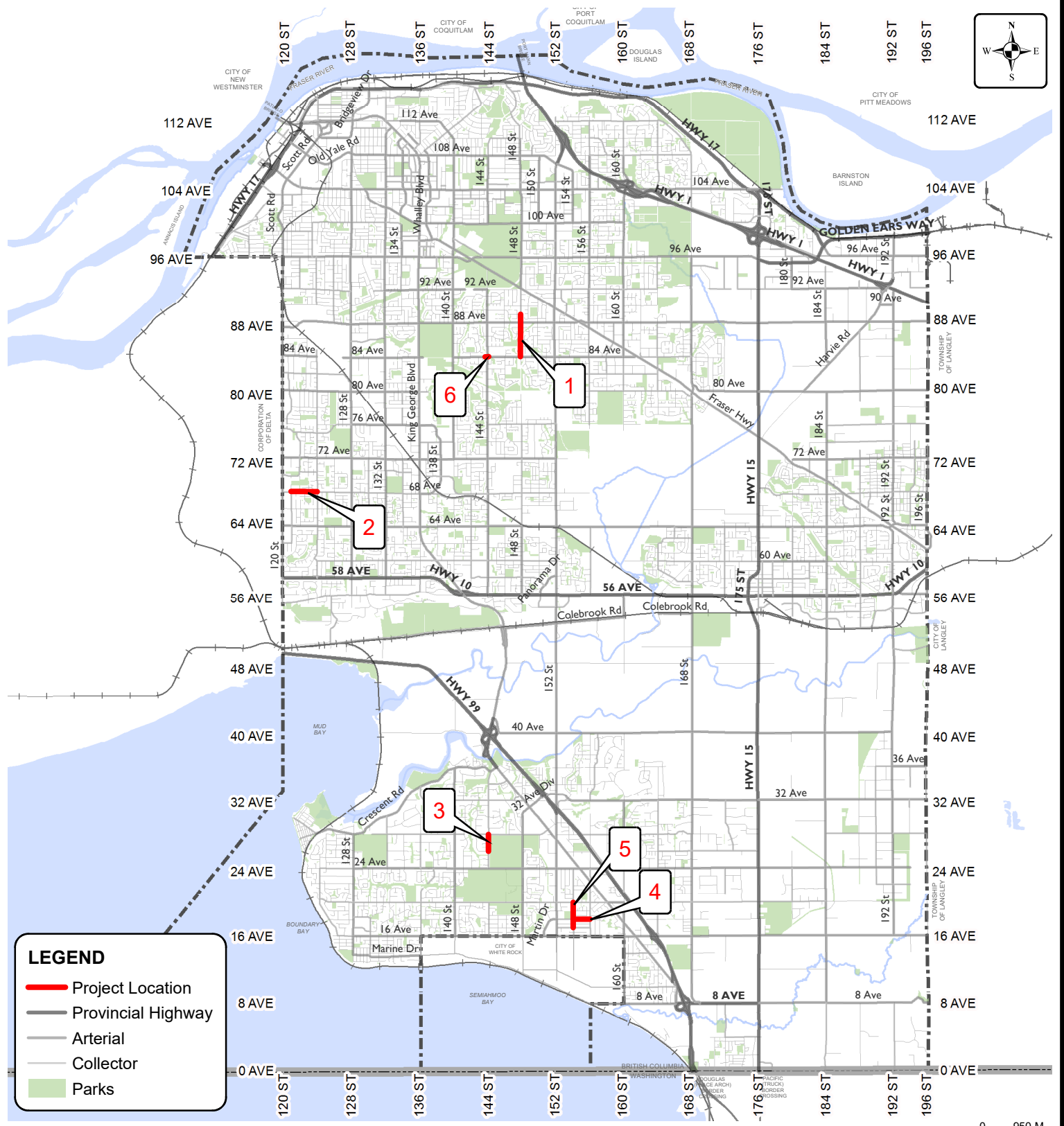
