250 feet North + South of the Sunnyside Rd.
+ 150 feet Back from the K G Business.

Residential from 250 feet North of the
Sunnyside Rd to 150 feet South of Johnston Rd.

150 feet North + South of Johnston Rd Business.

From 150 feet North of the Johnston Rd to 150 feet
South of the New Mc Kellan Rd. Tourist Camps + Residential

No Commercial Buildings on the
Superior or Niamek Rivers within
1000 feet of the K G Highway.

New Mc Lellan Rd 150 feet North
and South Business. Bldgs to be 25 feet
back from Highway.

150 feet North of the New Mc Lellan Rd.
to 150 feet south of the Nichol Rd.
Residential &
150 feet North & South of Nichol Rd Business

to Fishers Fire Stop Business.

From Fishers Fire Stop to Sandell Rd.

From Sandell Rd to the Patullo Bridge.
Commercial + Industrial.

All Residences to be a minimum of 50 feet
from the Highway line and Poultry and
Animal Husbandry Buildings to be a
minimum of 200 feet from the Highway.
in newly developed areas.

Special attention to be paid to railroad
crossings and street intersections to see
new Buildings do not create a Traffic Hazard.
