A by-law to authorize the appointment of Officers and Employees to enforce City By-laws.

WHEREAS Section 251 of the <u>Municipal Act</u> provides that Council may provide by By-Law for the Officers and Employees that may be deemed necessary to carry on the good government of the City.

NOW, THEREFORE, the City Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Title

This By-Law may be cited as "Appointment of By-Law Enforcement Officers By-law, 1994, No. 12167".

2. Authority to Appoint

The Council may, from time to time, appoint by resolution By-Law Enforcement Officers, Animal Control Officers and Parking Patrollers.

3. <u>By-Law Enforcement Officers - Authority to Enforce</u>

The By-Law Enforcement Officers are authorized to enforce all By-Laws of the City, as amended from time to time, and enter at all reasonable times on to any property or premises to ascertain whether the regulations and provisions of the said By-Laws are being or have been complied with.

3.1 <u>Animal Control Officers – Authority to Enforce</u>

The Animal Control Officers are authorized to enforce the following By-laws, as amended from time to time, and enter at all reasonable times on to any property or premises to ascertain whether the regulations and provisions of the said By-laws are being or have been complied with:

- Surrey Dog Responsibility By-law, 1999, No. 13880
- Surrey Pound By-law, 1958, No. 1669
- Surrey Noise Control By-law, 1982, No. 7044
- Surrey Dog Responsibility By-law, 2009, No. 16656

4. Parking Patrollers - Authority to Enforce

The Parking Patrollers are authorized to enforce the following By-law, as amended from time to time, and enter at all reasonable times on to any property or premises to ascertain whether the regulations and provisions of such By-laws are being or have been complied with:

- Highway and Traffic By-law, 1997, No. 13007.

5. Service of Summons

The By-law Enforcement Officers, Animal Control Officers and Parking Patrollers are authorized to serve a summons in respect of an alleged offence under a by-law for the purposes of Section 28(3) of the Offence Act, R.S.B.C. 1996, c. 338.
