## The Refund Policies

Scenario	Refund
1. Permit applied for but not issued yet	35% permit application fee is non-refundable
2. Permit applied for and issued (no construction commenced)	50% refund
3. Permit applied for and issued + Revision permit(s) taken Only revision(s) cancelled but original stays the same	No refund of Revision fee which are non-refundable
4. Permit applied for and issued + Revision permit(s) taken All permits are cancelled including original permit & revision(s)	50 % refund of all fees with the exception of Revision fee(s) which are non-refundable
