

**Picnic in the Past Photo Contest Rules and Regulations**  
**For Historic Stewart Farm**

**1) ENTRY PERIOD:** The Contest begins at July 2, 2018.

**2) ELIGIBILITY:** You must be nineteen (19) years or older and a legal resident in the province of British Columbia to enter this Contest. City of Surrey employees and immediate family members of City of Surrey employees are not eligible to enter.

**3) HOW TO ENTER:** Between July 1 and September 7, 2018, post your Picnic in the Past photos to Instagram with the hashtag #picnicinthepast.

You may enter a maximum of three (3) times.

This Contest is in no way sponsored, administered, or associated with Instagram. By entering, entrants confirm that they are 19+ years of age, release Instagram of responsibility, and agree to Instagram's terms of use.

**4) ENTRY GUIDELINES:** Comments (including photos) must be your own. Previously published material for which non-exclusive rights were granted may be entered as long as you still maintain the right to grant us a license. Late or corrupt entries will not be accepted.

Your entries must not be obscene or otherwise inappropriate, as determined by the City of Surrey in its sole discretion. Entries that are deemed inappropriate will not be accepted. You are responsible for obtaining, prior to submitting any entry, any releases and consents necessary to permit the exhibition and use of the entry in the manner described in these Official Rules without additional compensation.

If any person appearing in any photo is under the age of majority in their province of residence the signature of a parent or legal guardian is required on each release.

**5) PRIZES:** There will be three (3) Prize Winners. Each prize will be a picnic basket and a picnic blanket.

The Prize must be accepted as awarded and is non-transferable. No substitution of the Prize is permitted. The Prize cannot be returned or exchanged for a cash refund.

**6) WINNERS AND ODDS:** Three (3) Prize Winners will be drawn after September 7, but before June 2, 2018, from all eligible entries received. The odds of winning depend upon the number of eligible entries. The Winners will be chosen by random draw. Winners must answer a skill-testing question to claim the prize. The City of Surrey is not responsible for and will not be liable for late, lost, misdirected, or unsuccessful efforts to notify the selected Entrant. If a selected entrant cannot be contacted or fails to respond within 72 hours the City of Surrey reserves the right to void that entry and select another eligible entrant for the Prize.

**7) INTELLECTUAL PROPERTY:** Upon submission of your entry to the Contest, you irrevocably grant to the City of Surrey the non-exclusive, perpetual, royalty-free, no-cost license and right to use your entry in any medium including streaming media, film, television, print, interactive devices, mobile media,

Internet and on-line systems, and digital billboards. The City of Surrey will have the right to use your entry in any merchandising, advertising, marketing, or promotion. You agree that the City of Surrey shall have the sole discretion in determining the extent and manner of use of entries and are not obligated to use any entry. You understand that all entries that are posted on the City of Surrey's website and related social media may be available to be viewed by anyone with access to the Internet.

**8) TERMS AND CONDITIONS:** By participating, you agree to a) abide by the Official Rules and the decisions of the City of Surrey, which shall be final in all respects; and b) release, discharge and hold harmless the City of Surrey from all liability, claims or damages, arising out of your participation in the Contest and the acceptance, use or misuse of a prize. The City of Surrey reserves the right to cancel or suspend this Contest, and cancel or refuse any entry or any individual winning the Contest.

**9) PRIVACY:** Personal Information is collected for the purposes of receiving your contest entry and inviting you to engage with the City of Surrey for the 'Picnic in the Past Photo Contest.' The City of Surrey is collecting this information under s.26 (c) of the *Freedom of Information and Protection of Privacy Act*.
