  Delete from note: "Tie in to existing rectangular cast in place concrete sanitary manhole" and replace with "Remove existing cast in place sanitary manhole and install new 1050 dia sanitary manhole." Support and protect existing landscape retaining wall adjacent.
- 3. Reference Tender Drawings, Sheet 05, for new hydrant at 1+090, add "complete with wet tap to existing 250 mm water."
- 4. Reference Contract Documents, Supplementary Specifications (Project), SSP 17, General Requirements, add "Any and all work on or crossing arterial roads shall be done at night or between the hours of 9 am to 3 pm. CMB's are required for these areas where any work is done on or crossing arterial roadways."
- Reference Tender Form, Schedule of Quantities and Prices, Section 14
   For item 1.2.1, change quantity to 2.0 each
   For item 1.2.2, change quantity to 3.0 vert meters
