

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 7289

A by-law to designate certain land together with the building thereon as a municipal heritage site for the purpose of preserving evidence of the Municipality's history, culture and heritage for the education and enjoyment of present and future generations.

WHEREAS the "Heritage Conservation Act" being Chapter 165 R.S.B.C., 1979, provides that the Council may, by By-law, designate a building, structure or land, in whole or in part, as a municipal heritage site;

AND WHEREAS it is deemed expedient that the following land together with the building thereon be preserved and that the said land together with the building thereon be designated by the Council as a municipal heritage site for such purpose for the education and enjoyment of present and future generations.

THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, and in pursuance of the authority of Section Eleven (11) subsection one (1) of the "Heritage Conservation Act" ENACTS AS FOLLOWS:

1. This By-law may be cited for all purposes as "Surrey Municipal Heritage Site Designation By-law, 1982, No. 7289".
2. The following described parcel of land, together with the buildings thereon, is hereby designated as a Municipal Heritage Site for the purpose of preserving evidence of the Municipality's history, culture and heritage for the education and enjoyment of present and future generations, namely:

The South Sixty-Five (65) metres of Lot Thirty-One (31) of the North West Quarter (NW 1/4) of Section Eight (8), Township Eight (8), Plan Forty-Four Thousand Two Hundred Fifty-Four (44254), New Westminster District, being measured perpendicularly to the southern boundary thereof.

Location: North East corner of 60th Avenue and 176th Street.


This property is the site of the Old Haddon Mill and the building on the site is the present Surrey Museum which contains, within the building structure, the first Municipal Hall which was constructed in 1881 and was originally sited at Surrey Centre on the present site of the Surrey School Board Works Yard.


and all provisions of the "Heritage Conservation Act" being Chapter 165 R.S.B.C., 1979, shall apply to the said parcel of land from the date of the final adoption of this By-law.

PASSED BY THE MUNICIPAL COUNCIL on the 30th day of August, 1982.

ADVERTISED in the Surrey Leader newspaper on the 15th day of September , 1982, and on the 22nd day of September , 1982.
