THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10433

A by-law to amend the provisions of
"Sewer Frontage Tax By-law, 1964, No.
2183" as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. "Sewer Frontage Tax By-law, 1964, No. 2183", as amended is hereby further amended as follows:
- (a) The preamble is hereby amended in the second line by deleting the word "frontage" and inserting the word "parcel" in its place.
- (b) The third WHEREAS clause is hereby amended in the first line by deleting the figure "532" and inserting the figure "612" in its place.
- (c) A WHEREAS clause is hereby inserted between the third WHEREAS clause and the fourth WHEREAS clause as follows:
- "AND WHEREAS Section 482 provides that Council may, instead of imposing a frontage tax, impose a tax with respect to each parcel at the same rate for each parcel."
- (d) The fourth WHEREAS clause is hereby amended in the first, second and third lines by deleting the words and figures "actual metre frontage is 1,106.642.777 metres and the taxable metre frontage is 1,143,540.00 metres" and inserting the words and figures "number of taxable parcels is 57,169" in their place.
- (e) The fourth WHEREAS clause is hereby further amended in the fourth line by deleting the word "frontage" and inserting the words "parcel tax" in its place.
- (f) The fourth WHEREAS clause is hereby further amended in the sixth line by deleting the figure "1988" and inserting the figure "1989" in its place.
- (g) The fourth WHEREAS clause is hereby further amended by deleting the tables and inserting the tables in their place as follows:

- (h) Section 1 is hereby amended as follows:
- (i) The first and second line are hereby amended by deleting the words and figures "A frontage tax of Three Dollars and Ninety Cents (\$3.90) per taxable metre frontage" and inserting the words and figures "A parcel tax of Seventy-Eight Dollars (\$78.00) per parcel" in their place.
- (ii) Section 1 is hereby further amended in the fourth line by deleting the figure "481" and inserting the figure "482" in its place.
 - (iii) Section 1 is hereby further amended by deleting the second paragraph in its entirety.
 - (i) Section 2 is hereby deleted in its entirety.
 - (j) Section 3 is hereby deleted and the following Section 3 is hereby inserted in its place as follows:
- "3. The Collector or some other person appointed by Council is hereby directed to prepare a parcel tax assessment roll pursuant to Part 10 of the "Municipal Act".
- (k) Section 4 is hereby amended in the title by deleting the word "Frontage" and inserting the word "Parcel" in its place.
- 2. This By-law shall be cited for all purposes as "Sewer Frontage Tax By-law, 1964, No. 2183, Amendment By-law, 1990, No. 10433."
