

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10262

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS Charles Alfred Higham and Gretta Muriel Higham are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said Charles Alfred Higham and Gretta Muriel Higham the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in Charles Alfred Higham and Gretta Muriel Higham, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

That portion of road in Section 34, Block 5 North, Range 1 West, dedicated by Plan 2619A, New Westminster District shown within the heavy dark outline on an Explanatory Plan prepared by J.G. Cameron on October 19, 1989, and containing 154.5 square metres.

(Portion of 159 Street between 99A Avenue and 100 Avenue)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from Charles Alfred Higham and Gretta Muriel Higham, in exchange for the land mentioned in Section One (1) hereof, the sum of Two Thousand Three Hundred Twelve Dollars (\$2,312.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that part of Lot 2, Section 34, Block 5 North, Range 1 West, New Westminster District now included in heavy dark outline and shown hatched on an Explanatory Plan prepared by J.G. Cameron, B.C.L.S. on the 19th day of October, 1989 and containing 66.11 square metres, a copy of which is hereto attached.

(Portion of 15916 - 100 Avenue)

3. This By-law may be cited for all purposes as "159 Street/100 Avenue Road Exchange By-law, 1990, No. 10262."
