A by-law to dispose of portions of a
public highway in exchange for adjoining
lands necessary for a public highway.

WHEREAS THE CORPORATION OF THE DISTRICT OF SURREY are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

l. Upon receiving from the said CORPORATION OF THE DISTRICT OF SURREY the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in the CORPORATION OF THE DISTRICT OF SURREY, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

All that portion of Lot "A", Section Seven (7), Township Two (2), Plan Eighty-Two Thousand Six Hundred Ninety-Six (82696), New Westminster District, shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk prepared by Peter M. Mueller, B.C.L.S. on September 26, 1989, and containing Two Thousand One Hundred Forty and Eight-Tenths (2140.8) square metres.

(Portion of 6265 Boundary Drive East)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from the CORPORATION OF THE DISTRICT OF SURREY, in exchange for the land mentioned in Section One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that portion of road in Section Seven (7), Township Two (2), New Westminster District, dedicated by Plan Two Thousand Three Hundred Sixty-Five (2365), shown hatched on Reference Plan attached hereto duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on September 26, 1989, and containing Four Thousand Seventy-Two and Seven-Tenths (4072.7) square metres.

(Portion of 62 Avenue, west of 124 Street)

3. This By-law may be cited for all purposes as "62 Avenue/Boundary Drive East Road Exchange By-law, 1989, No. 10320."
