(15812 Norfolk Road)
at or for the sum of Fifty Two Thousand Two Hundred Dollars (\$52,200.00) plus tax adjustment and conveyancing costs.
2. Upon receipt of good and valid conveyance of said lands in favour of the Corporation, the Mayor and Treasurer are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore mentioned.
3. Upon conveyance of the lands described in Section One (l) hereof to the Corporation, the same shall be and it is nereby declared to be set aside and used for Corporate purposes.
4. This By-law may be cited for all purposes as "Land Purchase By-law, 1990, No. 10491."
