For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from VICTOR HEYDE AND ADELINE HEYDE, in exchange for the land mentioned in Section One (l) hereof, the sum of Eight Thousand Nine Hundred Twenty-Eight Dollars (\$8,928.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that part of Lot 27, Section 34, Block 5 North, Range 1 West, Block 9, New Westminster District, Plan 13887, now included in heavy dark outline and shown hatched on an Explanatory Plan, prepared by J.G. Cameron, B.C.L.S. on the 19th day of October, 1989, and containing 21.47 square metres.
