<u>BY-LAW NO. 10542</u>

A by-law to authorize the dedication of land owned by The Corporation of the District of Surrey for use as a public highway.

WHEREAS the land hereinafter described is required for use as a public highway;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. The following land, all in the Municipality of Surrey, Province of British Columbia:

A reference plan will accompany the following described portions of Section Nine (9), Township Two (2), New Westminster District, shown outlined in heavy black line, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on March 21, 1990, and attached hereto;

That portion of the East Two Hundred (200) feet, Legal Subdivision two (2), containing One Hundred Twenty-Three and Five-Tenths (123.5) square metres.

(Portion of 14193 - 56 Avenue

That portion of the West Half of the West Half Legal Subdivision one (1), containing Five Hundred Sixty-Nine and Eight-Tenths (569.8) square metres.

(Portion of 14245 - 56 Avenue)

Those portions of the East Half of the West Half Legal Subdivision One (1) containing;

FIRSTLY; Seventy-Two (72.0) square metres

SECONDLY; Five Hundred Seventy (570.0) square metres.

(Portions of 14275 - 56 Avenue)

Those portions of Lot three (3), Plan Eight Thousand Eighty-Six (8086), containing; <u>FIRSTLY</u>, Fifty-Seven and Seven-Tenths (57.7) square metres

(Portion of 14343 - 56 Avenue)

That portion of Lot Twenty-One (21), Plan Twenty Seven Thousand Two Hundred Twenty-Three (27223), containing One Hundred Sixty-Five and Five-Tenths (165.5) square metres.

(Portion of 5645 -144 Street)

That portion of Parcel 'A' (Explanatory Plan Fifteen Thousand Seven Hundred Sixty (15760) of Lot Six (6), Plan Eight Thousand Eighty-Six (8086), containing One Hundred Fifty-Seven and Six-Tenths (157.6) square metres.

(Portion of 5647 -144 Street)

That portion of Lot Five (5), Plan Eight Thousand Eighty-Six (8086), containing Six Hundred Fifty-Four and Three-Tenths (654.3) square metres.

(Portion of 5677 -144 Street)

That portion of Lot Two (2), Plan Eight Thousand Eighty-Six (8086), containing Nine Hundred Eighty-Two and Six-Tenths (982.6) square metres.

(Portion of 5711 -144 Street)

is hereby declared to be set aside and used by The Corporation of the District of Surrey as a public highway only.

2. A reference plan will accompany this By-law for registration purposes, outlining the above property in black, and duly signed by the Mayor and Clerk.

- 3. "Road Dedication By-law, 1990, No. 10235" is hereby repealed.
- 4. This By-law may be cited for all purposes as "Road Dedication By-law, 1990, No. 10542."
