BY-LAW NO. 10551

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS HERON ENTERPRISES LTD. is the owner of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said HERON ENTERPRISES LTD. the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in HERON ENTERPRISES LTD., ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

All that portion of Section 30, Township 2 dedicated as road on Plan 58453 deposited New Westminster District, shown outlined bold and hatched on Plan containing 52.80 square metres more or less.

(Portion of 120A Street north of 82 Avenue)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from HERON ENTERPRISES LTD., in exchange for the land mentioned in Section One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that portion of Lot 3, Section 30, Township 2, New Westminster District, Plan 58453, shown outlined bold and hatched on Plan containing 382.1 square metres more or less.

(Portion of 8256 - 120A Street)

3. This By-law may be cited for all purposes as "120A Street Road Exchange By-law, 1990, No. 10551."
