THE CORPORATION OF THE DISTRICT OF SURREY

<u>BY-LAW NO. 10566</u>

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS LEONARD ELMER BERGEN and SOLVEIG ALVIDE BERGEN are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said LEONARD ELMER BERGEN and SOLVEIG ALVIDE BERGEN the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in LEONARD ELMER BERGEN and SOLVEIG ALVIDE BERGEN, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

That portion of road in Section Nine (9), Township Eight (8), dedicated by Plan Seventy-Nine Thousand Four Hundred Forty-Five (79445), New Westminster District, shown hatched on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Henry A.R.P. Aldridge, B.C.L.S., on April 17, 1990, and containing One Hundred Forty-Nine and Four Tenths (149.4) Square metres.

(Portion of 60 Avenue West of 186 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from LEONARD ELMER BERGEN and SOLVEIG ALVIDE BERGEN, in exchange for the land mentioned in Clause One (l) hereof, the sum of Four Thousand Eight Hundred Twenty-Two Dollars Sixty-Three Cents (\$4,822.63), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Lot One Hundred Nineteen (119), Section Nine (9), Township Eight (8), Plan Seventy-Nine Thousand Four Hundred Forty-Five (79445), New Westminster District, shown within heavy outline on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Henry A.R.P. Aldridge, B.C.L.S., on April 17, 1990, and containing One and Two Hundred Thirty-Six One Thousandths (1.236) Square Metres. (Portion of 18585 - 60 Avenue)

3. This By-law may be cited for all purposes as "60 Avenue/186 Street Road Exchange By-law, 1990, No. 10566."
