

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10649

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS WALTER GOERTZ CONSTRUCTION LTD. are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said WALTER GOERTZ CONSTRUCTION LTD. the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in WALTER GOERTZ CONSTRUCTION LTD., ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

All that Part of Road in Section 17, Township 8, New Westminster District, dedicated by Plan 1838 shown hatched and outlined in heavy black line on the Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by J.J. Ward, British Columbia Land Surveyor, on the 20th day of February 1990 and containing 924.2 Square Metres.

(Portion of 65A Avenue west
of 179 Street)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from WALTER GOERTZ CONSTRUCTION LTD., in exchange for the land mentioned in Clause One (1) hereof, the sum of TWENTY THOUSAND FOUR HUNDRED FORTY-SIX DOLLARS (\$20,446.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

All that Part of Lot 14, Section 17, Township 8, New Westminster District, Plan 78706 shown outlined in heavy black line on the Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by J.J. Ward, British Columbia Land Surveyor, on the 20th day of February 1990 and containing 18.10 Square Metres.

(Portion of 6553 - 179 Street)

3. This By-law may be cited for all purposes as "65A Avenue/79 Street Road Exchange By-law, 1990, No. 10649."
