THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10684

A by-law to authorize the purchase of land required for Corporate purposes and to dedicate certain of the said land for use as a public highway.

.....

WHEREAS the land hereinafter described is required for the purpose of the Corporation;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. The Corporation of the District of Surrey is hereby authorized to purchase from the owner or owners thereof, respectively, the following land, all in the Municipality of Surrey, Province of British Columbia:

All those Portions of Section Twenty-Nine (29), Block Five (5) North, Range One (1) West, New Westminster District, shown within heavy black outline on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on September 14, 1990, described as follows:

That Portion of the West Half Lot 'D', Plan Thirteen Thousand Seven Hundred Thirty (13730), containing Eighty-Eight and Nine-Tenths (88.9) square metres

(Portion of 14957 - 100 Avenue)

at or for the sum of Sixteen Thousand Twenty-Nine Dollars (\$16,029.00) plus tax adjustments and conveyancing costs.

That Portion of the East Half Lot 'D', Plan Thirteen Thousand Seven Hundred Thirty (13730), containing Eighty-Eight and Nine-Tenths (88.9) square metres

(Portion of 14969 - 100 Avenue)

at or for the sum of Sixteen Thousand Twenty-Nine Dollars (\$16,029.00) plus tax adjustments and conveyancing costs.

That Portion of the Common Property of Strata Plan NW One Thousand Nine Hundred Ninety-Three (NW

1993), containing Ninety-One and Three-Tenths (91.3) square metres

(Portion of 10011 - 150 Street)

at or for the sum of Seventeen Thousand One Hundred Ninety-Nine Thousand Dollars (\$17,199.00) plus tax adjustments and conveyancing costs.

- 2. Upon receipt of good and valid conveyance of said land in favour of the Corporation, the Mayor and Treasurer are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore mentioned.
- 3. Upon conveyance of the land described in Section One (l) hereof, to the Corporation, the same shall be and it is hereby declared to be set aside and used by The Corporation of the District of Surrey as a public highway only.
- 4. A reference plan will accompany this By-law for registration purposes, outlining the above property in black, and duly signed by the Mayor and Clerk.
- 5. This By-law may be cited for all purposes as "Land Purchase And Highway Dedication By-law, 1990, No. 10684."
