THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10815

A by-law to dispose of portions of a public
highway in exchange for adjoining lands
necessary for a public highway.

WHEREAS Samuel Tichonow and Sharon Ann Ivey are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

l. Upon receiving from the said Samuel Tichonow and Sharon Ann Ivey the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in Samuel Tichonow and Sharon Ann Ivey, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

That portion of road in Section Twenty (20), Block Five (5) North, Range Two (2) West, New Westminster District, dedicated by Plan Five Hundred Seventeen (517) shown hatched on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by K.T. Naylor, B.C.L.S., on December 13, 1990, and containing two-hundred thirty-eight and eight-tenths (238.8) square metres.

(Portion of 124 Street south of Old Yale Road).

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from Samuel Tichonow and Sharon Ann Ivey, in exchange for the land mentioned in Clause One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

A reference plan will accompany the following described portion of Lot One (1), Block One (1), Section Twenty (20), Block Five (5) North, Range Two (2) West, New Westminster District, Plan Five Hundred Seventeen (517), shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by K.T. Naylor, B.C.L.S. on December 13, 1990, and containing seventy-four and three-tenths (74.3) square metres.
