BY-LAW NO. 10889

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS The Corporation of the District of Surrey are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

l. Upon receiving from the said Corporation of the District of Surrey the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in The Corporation of the District of Surrey , ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

Those portions of road in District Lot Three Hundred Eighty-Seven (387) 'A', Group Two (2), New Westminster District, shown hatched on reference plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S., on January 29, 1991, and more particularly described as follows;

That portion of road in Block One (1) dedicated by Plan Two Hundred Seventy-Two (272), containing three thousand eight hundred forty-two and seven-tenths (3842.7) square metres.

(Portion of 98 Avenue east of 192 Street)

That portion of road in Blocks Two (2) and Four (4) dedicated by Plan Three Hundred Forty-Three (343), containing three thousand three hundred fifty-three and three-tenths (3353.3) square metres.

(Portion of 98 Avenue and 193 Street east of 192 Street).

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from The Corporation of the District of Surrey, in exchange for the land mentioned in Section One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

That portion of Block Four (4), District Lot Three Hundred Eighty-Seven (387) 'A', Group Two (2), Plan Two Hundred Seventy-Two (272), New Westminster District, shown outlined in heavy black line on reference plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S., on January 29, 1991, and containing thirteen and four-fenths (13.4) square metres.

(Portion of 19307 - 96A Avenue)

3. This By-law may be cited for all purposes as "98 Avenue/ 96 Avenue Road Exchange By-law, 1991, No. 10889".
