THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10941

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

WHEREAS MARK W. ANKENMAN JR. is the owner of the land described in Section 2 of this By-law and has agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said MARK W. ANKENMAN JR. the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in MARK W. ANKENMAN JR., ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia.

A reference plan will accompany the following described portions of road lying in Section Eight (8), Township One (1), New Westminster District, shown hatched on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on the 10th day of May 1991, and described as follows:

That portion of road dedicated by Plan Two Thousand Seven Hundred Fifteen (2715), containing Three Hundred Two and Six-Tenths (302.6) square metres.

(Portion of 131 Street, south of 13 Avenue)

That portion of road dedicated by Plan Four Thousand Eight Hundred Twenty-Eight (4828), containing Two Hundred Eighty-Seven and Five-Tenths (287.5) square metres.

(Portion of 131 Street, south of 13 Avenue)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from MARK W. ANKENMAN JR., in exchange for the land mentioned in Section One (l) hereof, the sum of One Dollar (\$1.00), together with such conveyance or other assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

A reference plan will accompany the following described portion of Lot Nine (9), Block Seven (7), Section Eight (8), Township One (1), Plan Two Thousand Seven Hundred Fifteen (2715), New Westminster District, shown outlined in heavy black line on Reference Plan attached hereto, duly signed by the Mayor and Clerk, prepared by Peter M. Mueller, B.C.L.S. on the 10th day of May 1991, and containing Five Hundred Ninety and One-Tenth (590.1) square metres.

(Portion of 13088 - 13 Avenue)

3. This By-law may be cited for all purposes as "13 Avenue/131 Street Road Exchange By-law, 1991, No. 10941."
