(18522 - 60 Avenue)
(b) Lot 13, Section 24, Block 5 North, Range 1 West, New Westminster District, Plan 86727
(16491 - 104th Avenue)
(c) Lot 9, Section 23, Block 5 North, Range 1 West, New Westminster, Plan 68877
(16150 Brookside Grove)
at or for the sum of One Dollar (\$1.00) in each instance, plus tax adjustment and conveyancing costs.
2. Upon receipt of good and valid conveyance of said lands in favour of the Corporation, the Mayor and Treasurer are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore mentioned.
B. Upon conveyance of the lands described in Section One (l) hereof to the Corporation, the same shall be and it is hereby declared to be set aside and used for Corporate purposes.
H. This By-law may be cited for all purposes as "Land Purchase By-law, 1992, No. 11344."
