SUBJECT: Award of Contract No. 4718-011-11

Miscellaneous Sanitary Sewer and Water Main Upgrades

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 4718-011-11 to Sandpiper Contracting LLP for the amount of \$2,742,570.60 (including GST) for the construction of new sanitary sewers at various locations plus one water main;
- 2. Set the expenditure authorization limit for Contract No. 4718-011-11 at \$3,170,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 4718-011-11.

SCOPE OF WORK

The construction package related to this Contract consists of the installation of sanitary sewer at six locations and a water main at one location, which are also illustrated on the map attached to this report as Appendix "I":

The Contract work is expected to start in March 2019 and be completed by October 2019. There are no planned road closures or prolonged impacts to any residences or businesses resulting from any of the Contract work.

TENDER RESULTS

Tenders for the subject Contract were opened on December 18, 2018 with the following results:

The Engineer's (ISL Engineering) pre-tender estimate was \$3.3 million (including GST).

EVALUATION

The City received five Tender Submissions and upon review for accuracy and completeness, one of the Tenders had a minor arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Sandpiper, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond and agreed to complete the work within 120 working days, as stipulated in the Contract. They have no outstanding legal claims against the City. It is recommended that Sandpiper be awarded Contract No. 4718-011-11.

SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, this work relates to the Sustainability Charter 2.0 theme Infrastructure. Specifically, this Contract supports the following Strategic Direction ("SD") Desired Outcome ("DO"):

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems; and
- All Infrastructure SD1: Proactively manage community assets to maintain them over the long-term in a state of good repair.


FUNDING
