RECOMMENDATION

The Parks, Recreation & Culture Department and the Finance Department recommend that Council:

- 1. Receive this report for information; and
- 2. Approve funding in the amount of \$500 from the Council Initiatives Fund, to support Special Olympics BC.

INTENT

The purpose of this report is to provide an update on the City's partnership with Special Olympics BC and activities and request Council support funding in the amount of \$500 as requested by a delegation at the Council-In-Committee Meeting of June 24, 2019.

BACKGROUND

The City has a longstanding relationship with Special Olympics BC. Currently, Special Olympics BC runs a swimming program for people with intellectual disabilities operated out of South Surrey Indoor Pool and North Surrey Recreation Centre. The organization also operates five sport programs across Surrey within School District facilities.

Since 2018, the City hosted the following three events in partnership with Special Olympics BC:

- October of 2018: The City hosted the first Champions for Health Coalition Forum, an event where over 75 individuals representing organizations from across the lower mainland came together to develop a framework to ensure that person with intellectual disabilities have positive health outcomes;
- March 9, 2019: A Family Health Forum was held at City Hall, providing athletes and their families information on healthy eating habits and training; and
- May of 2019: The City hosted a coaching course at City Hall, certifying 21 new coaches to facilitate sport programming to Special Olympic athletes.

DISCUSSION

Special Olympics BC has over 400 athletes in Surrey in 18 sport programs. Funding received will directly support Surrey's 60 registered children under the age of 12 with intellectual disabilities. Specifically, \$500 provided to Special Olympics BC will go towards the purchase of equipment and annual facility rental costs in Surrey to support existing school-based and community-based programming that introduce sport, health and social interaction to children.

FUNDING

Council Initiatives Fund

As part of the City's 2019 Operating budget \$ 260,000 is allocated to Council Initiatives Fund. This fund is utilized at the discretion of Council to support community initiatives, emerging priorities and other events supported by Council. It is recommended that Council approve a funding allocation of \$500 from Council Initiatives Fund to Special Olympics BC with their purchase of equipment for their school-based community programs and facility rental costs. Appendix "II" attached to this report documents the balance of the Council Initiatives Fund based on an assumption that Council will approve the recommendations of this report.

SUSTAINABILITY CONSIDERATIONS

This event supports the objectives of the City's Sustainability Charter 2.0. In particular, this event relates to Sustainability Charter 2.0 themes of Inclusion and Education & Culture. Specifically, the event supports the following - Desired Outcomes ("DO"):

- Diversity & Accessibility DO1: Surrey welcomes, includes and embraces and values the diversity of people who live here;
- Diversity & Accessibility DO2: Surrey is a caring and compassionate city that learns about and supports its residents of all backgrounds, demographics and life experiences;
- Diversity & Accessibility DO3: Residents have opportunities to build social connections with people from different backgrounds;
- Community Pride & Engagement DO20: Surrey residents are proud of their community;
- Community Pride & Engagement DO21: All residents have opportunities to be meaningfully engaged in civic issues to and to contribute to community life;
- Learning DO1: Surrey has a culture of learning, with a broad range of diverse learning opportunities available and accessible to meet the needs of all residents;
- Learning DO2: Surrey children and youth have access to a high quality comprehensive and inclusive educational system, and opportunities that include experience in and out of school;
- Arts & Heritage DO 7: An enviable and vibrant arts and heritage sector contributes to Surrey's citizen engagement, enrichment, economy, community livability and civic pride; and
- Arts & Heritage DO9: Surrey supports and celebrates its diverse artists, cultures and community heritage through inclusive festivals, programing and events.

CONCLUSION

Based on the above discussion, it is recommended by the Parks, Recreation & Culture Department and the Finance Department that Council approve funding in the amount of \$500 to support Special Olympics BC.
