RECOMMENDATION

The Finance Department recommends that Council:

- 1. Receive this report for information; and
- 2. Approve a sponsorship contribution of \$2,500 in support of Simon Fraser University Community Lecture & Reception to be held on Wednesday, November 6th, 2019.

INTENT

Simon Fraser University ("SFU") Surrey has forwarded an invitation to the City to become a sponsor for a Community Lecture & Reception featuring Ms. Betsy Myers, to be held on Wednesday, November 6, 2019, at Surrey campus.

DISCUSSION

SFU Surrey is hosting a community lecture & reception featuring Ms. Betsy Myers on November 6, 2019, at its Surrey campus. Ms. Myers is a former Senior Adviser to two U.S. Presidents - Bill Clinton and Barack Obama. Ms. Myers is currently the Founding Director of the Center for Women in Business at Bentley University, Massachusetts. As a leadership expert, author and advocate, she speaks at conferences and workshops around the world on the changing nature of leadership. On November 6, 2019, Ms. Myers will be focusing on the Six Emerging Leadership Trends for the 21st Century. She will explain and analyze the six key trends that are causing disruption within the organizations worldwide and how to respond using a breakthrough leadership approach.

SFU is requesting that as a community partner, the City consider a sponsorship request of \$2,500 to help off-set the logistical costs of hosting the event at SFU's Surrey campus.. This level of sponsorship includes ten front-row tickets to the event which will be allocated to members of Council who plan to attend the event. In addition, the City will be acknowledged as a sponsor on the SFU website, social media platforms, displays at the lecture and during all formalities of the event. Appendix "I" includes the details of the sponsorship opportunities and sponsor benefits.

FUNDING

Staff have evaluated the current request to confirm it complies with the new Council Initiatives Fund Utilization Policy. Staff recommends that Council consider supporting the SFU Community Lecture & Reception through a sponsorship of \$2,500 from the Council Initiatives Fund contingent on the venue is in good standing with the City at the time of the event. The funding will be used to help off-set the logistical costs of hosting the event at SFU's Surrey Campus. Council has previously provided funding to similar events through the Council initiatives Fund.

Appendix "II" attached to this report documents the balance in the Council Initiatives Fund based on an assumption that Council will approve the recommendations of this report.

SUSTAINABILITY CONSIDERATIONS

The SFU Community Lecture & Reception supports the overall objectives of the City's Sustainability Charter 2.0 as related to the themes of Inclusion and Education and Culture. In particular, this sponsorship will support the following Desired Outcomes ("DO"):

- Inclusion DO1: Surrey welcomes, includes, embraces and values the diversity of people who live here;
- Inclusion DO2: Surrey is a caring and compassionate city that learns about and supports its residents of all backgrounds, demographics and life experiences;
- Inclusion DO3: Residents have opportunities to build social connections with people from different backgrounds;
- Education & Culture DO1: Surrey has a culture of learning, with a broad range of diverse learning opportunities available and accessible to meet the needs of all residents;
- Education & Culture DO2: Surrey children and youth have access to a high quality comprehensive and inclusive educational system, and opportunities that include experience in and out of school;
- Education & Culture DO6: Surrey is a provider of advanced education, producing cuttingedge research and cultivating leaders in innovative practices; and
- Education & Culture DO9: Surrey supports and celebrates its diverse artists, cultures and community heritage through inclusive festivals, programing and events.

CONCLUSION

Based on the above discussion, it is recommended that Council approve from the Council Initiatives Fund, a sponsorship contribution of \$2,500 in support of SFU Community Lecture & Reception to be held on Wednesday, November 6, 2019, at Surrey campus.
