SUBJECT: Award of Contract No. 4718-018-11

North Surrey Utility Improvements

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 4718-018-11 to Sandpiper Contracting LLP in the amount of \$2,313,411.66 (including GST) for the North Surrey Utility Improvements Phase 5;
- 2. Set the expenditure authorization limit for Contract No. 4718-018-11 at \$2,545,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 4718-018-11.

SCOPE OF WORK

The construction works consist of the replacement of undersized sanitary sewers and aging asbestos cement water mains at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The Contract permits construction from 7:00 a.m. to 10:00 p.m. in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044. The Contract does not include an option for contractors to work 24 hours a day, seven days a week, given this work is located in residential areas. However, in an effort to facilitate the work and accelerate construction, the Contract does allow for temporary road closures. There are no prolonged impacts to any residences resulting from the Contract work.

The Contract work is expected to start April 2020 and be completed by November 2020.

The Engineer's (ISL Engineering and Land Services Ltd.) pre-tender estimate was \$3.82 million (including GST).

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond and were signed and sealed on the Tender Form.

The low bidder, Sandpiper Contracting LLP, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 150 working days, as stipulated in the Contract. Sandpiper Contracting LLP's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Sandpiper Contracting LLP be awarded Contract No. 4718-018-11.

SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.o. In particular, this work relates to Sustainability Charter 2.o theme of Infrastructure. Specifically, this project supports the following Desired Outcomes ("DO") and Strategic Direction ("SD"):

• All Infrastructure Doi: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems;


Funding for this Contract is available in the approved 2020 Utilities Budget.
