## RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 4718-010-11 to Richco Contracting Ltd. in the amount of \$6,035,793.75 (including GST) for the 2020 Robson Utilities and Road Improvements project;
- 2. Set the expenditure authorization limit for Contract No. 4718-010-11 at \$6,639,373.13(including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 4718-010-11.

## SCOPE OF WORK

The construction package related to this Contract consists of the replacement of undersized sanitary and storm sewers and aging asbestos cement watermains. As well, this Contract includes coordinated road improvements along the street for one location. The project locations are listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The Contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044. The Contract does not include an option for contractors to work 24-hours a day, seven days a week as the work is located within a residential area.

The contract work is expected to start on May 2020 and be completed by February 2020.

The Engineers' (McElhanney Consulting Services Ltd. and ISL Engineering Ltd.) pre-tender estimate was \$6,816,000.00, including GST.

# **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. There were two arithmetic errors that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond and were signed on the Tender Form.

The low bidder, Richco Contracting Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 180 working days, as stipulated in the contract. Richco Contracting Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Richco Contracting Ltd. be awarded Contract No. 4718-010-11.

## SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, this work relates to Sustainability Charter 2.0 theme of Infrastructure. Specifically, this project supports the following Desired Outcomes ("DO") and Strategic Direction ("SD"):


Funding for this contract is available in the approved 2020 Utilities and Transportation Budget.
