Quibble Creek Pathway and Pedestrian Bridge

## **RECOMMENDATION**

The Engineering Department recommends that Council:

- 1. Award Contract No. 1717-006-11 to Dorosh Construction Ltd. in the amount of \$1,396,732.56 (including GST) for the Quibble Creek Pathway and Pedestrian Bridge;
- 2. Set the expenditure authorization limit for Contract No. 1717-006-11 at \$1,537,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1717-006-11.

## **BACKGROUND**

This Contract represents the final phase of a multi-phased program to achieve a continuous multi-use pathway for pedestrians, cyclists, and other non-motorized users along the Green Timbers Greenway. This phase will complete the final link of the Green Timbers Greenway resulting in a continuous 11 kilometre greenway which starts on 120 Street and Nordel Way and connects with the Tynehead Perimeter Trail located at 168 Street and 96 Avenue, as shown on the map attached as Appendix "I".

#### **SCOPE OF WORK**

The construction package related to this contract consists of the construction of a multi-use pathway and pedestrian bridge at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "II":

The Contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044. The Contract does not include an option for contractors to work 24-hours a day, seven days a week, as the work is located within a residential area.

The contract work is expected to start in August 2020 and be completed by December 2020.

#### **TENDER RESULTS**

Tenders for the subject contract were opened on June 23, 2020 with the following results:

The Engineer's (Associated Engineering Ltd.) pre-tender estimate was \$1.32 million, including GST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond and were signed on the Tender Form.

The low bidder, Dorosh Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 80 working days, as stipulated in the Contract. Dorosh Construction Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Dorosh Construction Ltd. be awarded Contract No. 1717-006-11.

#### SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, this work relates to the Sustainability Charter 2.0 themes of Built Environment and Neighbourhoods, and Infrastructure. Specifically, this Contract supports the following Desired Outcomes ("DO"):


Funding for this contract is available in the approved 2020 Transportation Budget.


