SUBJECT: **Award of Contract 1220-040-2021-090  
Supply and Delivery of Watermain and Sanitary Pipe and Fittings**

## RECOMMENDATION

The Engineering Department recommends that Council:

1. Award Contract No. 1220-040-2021-090 to EMCO Waterworks for the supply and delivery of watermain and sanitary sewer pipes and fittings in the amount of \$1,518,650.74 (including PST and GST);
2. Set the expenditure authorization limit for Contract No. 1220-040-2021-090 at \$1,595,000 (including PST and GST and contingency); and
3. Authorize the General Manager, Engineering to execute Contract No. 1220-040-2021-090.

## INTENT

The intent of this report is to obtain Council's approval to award Contract No. 1220-040-2021-090 (the "Contract") to EMCO Waterworks ("EMCO") for the supply and delivery of watermain and sanitary sewer pipe and fittings.

## DISCUSSION

The supply and delivery of the 4,090 lineal metres of watermain and sanitary sewer pipe, and related fittings, is required for an upcoming City's capital project along 20 Avenue, from 148 Street and King George Boulevard. The capital project is to replace aging and undersized utilities and will be constructed by the City's in-house construction crew.

## QUOTATION RESULTS

In accordance with the *Purchase and Expenditure Authorization Bylaw*, a Request for Quotations was issued and posted for the subject Contract on the BC Bid and City websites.

Quotations were opened on December 16, 2021, with the following results:

## **EVALUATION**

The RFQ evaluation team, including staff from both the Engineering Department and Finance Department, reviewed the quotations for accuracy and completeness. All submissions were signed on the Quotation Form and there were no errors or omissions. Bonding was not required for this quotation.

EMCO submitted the lowest quotation and can supply and deliver the pipe and fittings on time to meet the project construction schedule of May 2022. EMCO's past performance on similar purchases has been satisfactory. They have no outstanding legal claims against the City.

It is recommended that EMCO be awarded Contract No. 1220-040-2021-090 for the supply and delivery of 4,090 lineal metres of watermain and sanitary sewer pipe and related fittings.

## **SUSTAINABILITY CONSIDERATIONS**

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, the services that will be performed under this Contract relates to the Sustainability Charter 2.0 theme of Infrastructure. Specifically, this Contract supports the following Desired Outcome ("DO") and Strategic Direction ("SD"):

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable, and long lasting, and are effectively integrated into regional systems; and
- All Infrastructure SD1: Proactively manage community assets to maintain them over the long-term in a state of good repair.
