SUBJECT:	Award of Contract No. 1723-007-11 Major Road Network Paving			

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract No. 1723-007-11 to BA Blacktop Ltd. in the amount of \$4,259,586.29 (including GST), for Major Road Network Paving at various locations;
- 2. Set the expenditure authorization limit for Contract No. 1723-007-11 at \$4,690,000.00 (including contingencies and GST); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1723-007-11.

INTENT

The intent of this Corporate Report is to seek Council's approval to award an agreement for Major Road Network Paving.

DISCUSSION

Scope of Work

The construction package related to this Contract consists of repaving 21.9lane-km of Major Road Network ("MRN") roads to maintain a state of good repair. The locations are illustrated on the map attached to this report as Appendix "I" and are also listed in the table attached as Appendix "II".

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, *1982*, *No. 7044*. The contract includes nighttime paving in certain locations to avoid major traffic congestions.

Invitation to Tender Results

Tenders for the subject contract were opened on February 17, 2023 with the following results:

The Engineer's (R.F. Binnie & Associates Ltd.) pre-tender estimate was \$5.6 million (including GST).

Evaluation

The submissions were reviewed for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond and were signed on the Tender Form.

The low bidder, BA Blacktop Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 110 working days, as stipulated in the contract. BA Blacktop Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that BA Blacktop Ltd. be awarded Contract No. 1723-007-11.

Project Schedule

The Contract work is expected to start in April 2023, and be completed by September 2023.


Funding for this Contract is available in the proposed 2023 Transportation Budget.
