RECOMMENDATION

The Engineering Department recommends that Council:

Local Road Paving

- 1. Award Contract No. 1723-007-31 to All Roads Construction Ltd. in the amount of \$1,482,155.06 (including GST), for Local Road Paving at various locations;
- 2. Set the expenditure authorization limit for Contract No. 1723-007-31 at \$1,631,000.00, (including contingencies and GST); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1723-007-31.

INTENT

The intent of this Corporate Report is to seek Council's approval to award an agreement for Local Road Paving.

DISCUSSION

Scope of Work

The construction package related to this contract consists of repaving 12.7 lane-km of Local Roads to maintain a state of good repair. The locations are illustrated on the map attached to this report as Appendix "I" and are also listed in the table attached as Appendix "II".

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw, 1982, No. 7044*. The Contract includes nighttime paving in certain locations to avoid major impact on businesses, as well as short duration road closures.

Invitation to Tender Results

Tenders for the subject contract were opened on March 24, 2023, with the following results:

The Engineer's (R.F. Binnie & Associates Ltd.) pre-tender estimate was \$1.6 million (including GST).

Evaluation

The submissions were reviewed for accuracy and completeness. There were three arithmetic errors that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, and were signed on the Tender Form.

The low bidder, All Roads Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 70 working days, as stipulated in the contract. All Roads Construction Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that All Roads Construction Ltd. be awarded Contract No. 1723-007-31.

Project Schedule

The contract work is expected to start in May 2023, and be completed by August 2023.


FUNDING
