SUBJECT: Council Initiatives Funding Request - Rotary District 5050 Conference

RECOMMENDATION

The Finance Department recommends that Council:

- 1. Receive this report for information; and
- 2. Approve from the Council Initiatives Fund, a sponsorship contribution of \$10,000 in support of the Rotary District 5050 (the "District") annual conference to be held in Surrey from May 5 to 7, 2023.

INTENT

The District has forwarded an invitation to the City to become a Platinum sponsor for its annual conference to be held from May 5 to 7, 2023 at the Sheraton Guildford Hotel in Surrey.

BACKGROUND

The Rotary International District has 1.4 million members with over 46,000 clubs throughout the world. For the past many years, the members of the District have dedicated thousands of volunteer hours towards sustainable projects that promote protecting the environment, peace, women and children, health, and many other key projects that create lasting change across the globe and communities. The District extends from Everett Washington to the lower mainland through the Fraser Valley to Hope. The District has over 57 clubs, 2300 Rotarians and eight additional youth clubs that span the ages of 15 to 30 year olds. The District empowers changemakers of all ages, encouraging the development of member leadership skills and sustainable projects that are impactful in their communities.

DISCUSSION

Each year, a district conference is hosted by the District Governor. This year, the conference is being held in Surrey. This year's conference theme is "Imagine a Peaceful and Inclusive World". The key areas of focus for plenary speakers will be – Environment, Peace Initiatives, Sustainability, Diversity, Equity and Inclusivity. The District is requesting that the City consider supporting this year's conference as a Platinum sponsor by providing a sponsorship of \$10,000.

With this level of sponsorship, a VIP table will be reserved for members of the Council who plan to attend the event. The City will also be recognized in all social media posts. Full details of the sponsorship opportunities are attached in Appendix "I".

FUNDING

Staff have evaluated the current request to ensure it is compliant with the Council Initiatives Fund Utilization Policy. Staff recommend that Council support the annual Rotary District 5050 conference as a Platinum sponsor by providing a sponsorship contribution of \$10,000 from the Council Initiatives Fund. Appendix "II" attached to this report documents the balance in the Council Initiatives Fund based on an assumption that Council will approve the recommendations of this report.

CONCLUSION

Based on the above discussion, it is recommended that Council approve from the Council Initiatives Fund, a sponsorship contribution of \$10,000 in support of the District's annual conference to be held in Surrey from May 5 to 7, 2023.
