SUBJECT:	Award of Contract No. 1220-040-2023-014 West Village Energy Centre – Gas-Fired Hot Water	Boilers	

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract No. 1220-040-2023-014 to Le Groupe Simoneau Inc in the amount of \$3,178,028.00 (including applicable taxes), for supply and delivery of two new boilers;
- 2. Set the expenditure authorization limit for Contract No. 1220-040-2023-0014 at \$3,178,028.00 (including applicable taxes); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1220-040-2023-014.

INTENT

The intent of this report is to seek Council's approval to award a contract for the supply and commissioning of two new boilers for West Village Energy Centre ("WVEC").

DISCUSSION

Scope of Work

The work related to this contract includes the supply and commissioning of two gas-fired hot water boilers to be installed at WVEC at 13231 Central Avenue, as illustrated on the map attached to this report as Appendix "I".

Due to construction of new high-density buildings in City Centre, the demand for heating capacity has increased significantly, which has prompted the need to upgrade the boiler capacity at WVEC. The new 15 MW capacity boilers will replace two existing 5 MW boilers and will work in parallel with the remaining 5 MW boiler. The replaced boilers will be redeployed in a future energy center to support future growth in City Centre.

Quotation Results

Quotations for the subject contract were opened on April 19th, 2023, with the following results:

The Engineer's (FVB) pre-quotation estimate was \$2,600,000 (including applicable taxes) for the base boiler requirement, which did not include the optional cost for Ultra Low NOx burners.

Evaluation

The quotations were reviewed for accuracy and completeness.

It is recommended that Le Groupe Simoneau Inc be awarded Contract No. 1220-040-2023-014, with the expenditure authority to be based on award of the Ultra Low NOx burners, as staff anticipate Metro Vancouver is anticipated to make changes in air quality regulations that require this technology before the new boilers are operational in 2024.

Project Schedule

The supply of the boilers is expected 50 weeks after award of contract. The installation is expected to be completed by September 2024.

FUNDING

Funding for this Contract is available in the approved 2023 District Energy Budget.
