RECOMMENDATION

The Parks, Recreation, & Culture Department recommends that Council:

- 1. Award Contract No. 1220-020-2023-001 to Astroturf West Distributors Ltd. in the amount of \$772,800 including GST, for the supply and installation of synthetic turf at Tom Binnie Park.
- 2. Set the expenditure authorization limit for Contract No. 1220-020-2023-001 at \$850,080 including GST and contingency.
- 3. Authorize the General Manager, Parks, Recreation & Culture to execute Contract No. 1220-020-2023-001.

INTENT

The intent of this Corporate Report is to seek Council's approval to award a contract for the supply and installation of synthetic turf at Tom Binnie Park.

DISCUSSION

Scope of Work

The scope of work related to this contract consists of the removal and disposal of end-of-lifecycle synthetic turf, extraction, and collection of existing turf infill for reuse, remedial civil works on subgrade, and the supply and installation of replacement synthetic turf surface on Field # 1 at Tom Binnie Park. Project location illustrated as outlined in red in Appendix "I".

Tender Results

Tenders for the subject contract were received from four firms specializing in synthetic turf supply and installation and were opened on June 1, 2023, with the following results:

Evaluation

All four bids were compliant with the terms of the Invitation to Tender and were evaluated by a review team that included City staff and representatives from the Consultant team. The evaluation included consideration of the proponent's previous performance on similar projects, financial stability, product technical evaluation (including warranty provisions), understanding of project scope, demonstrated capability to deliver on project objectives, schedule, and financial submission.

The lowest bid is from Astroturf West Distributors Ltd. They have no outstanding legal claims against the City. It is recommended that Astroturf West Distributors Ltd. be awarded Contract No. 1220-020-2023-001.

Project Schedule

The contract work is expected to start in August, 2023 and be completed in October, 2023.


FUNDING
