SUBJECT: Council Initiatives Funding Request - The Centre for Child Development

RECOMMENDATION

The Finance Department recommends that Council:

- 1. Receive this report for information; and
- 2. Approve from the Council Initiatives Fund, a sponsorship contribution of \$3,000 in support of the 24th Annual Gala of Hope hosted by the Centre for Child Development (the "Centre").

INTENT

The Centre has forwarded a request to the City to provide a sponsorship contribution of \$3,000 towards their 24th Annual Gala of Hope held on October 14th, 2023, at the Coast Langley Hotel and Convention Centre.

BACKGROUND

The City has received a sponsorship request from the Centre for their 24th Annual Gala of Hope. This event has typically taken place in November and accordingly, staff receive the request for funding with adequate time to bring forward a corporate report prior to the event. However, this year, due to the timing of the event and the related request for funding, this request is coming to Council after the event.

DISCUSSION

The Centre is a non-profit organization that operates to overcome societal barriers for those with disabilities and to empower vulnerable children and families throughout the South Fraser Region. The Centre provides comprehensive, collaborative medical rehabilitation programs and multi-disciplinary therapeutic services to children with a wide range of abilities and conditions. Each year, the Centre hosts an annual fundraising event, namely, "Gala of Hope" to support vital services that are delivered to over 4,000 children with disabilities and special needs. The Centre is requesting the City consider a sponsorship contribution of \$3,000 to support the 2023 Gala of Hope.

FUNDING

Staff have evaluated the request to ensure it is compliant with the Council Initiatives Fund Utilization Policy. Staff recommend that Council consider supporting the 24th Annual Gala of Hope through a sponsorship of \$3,000 from the Council Initiatives Fund. Appendix "I" attached to this report, documents the balance in the Council Initiatives Fund based on the assumption that Council will approve the recommendations of this report.

CONCLUSION

Based on the above discussion, it is recommended that Council approve from the Council Initiatives Fund, a sponsorship contribution of \$3,000 in support of the 24th Annual Gala of Hope hosted by the Centre for Child Development.
