**Intersection Improvements Package** 

### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract No. 1723-002-11 to Crown Contracting Limited in the amount of \$2,764,400.10, (including GST) for the Intersection Improvements Package.
- 2. Set the expenditure authorization limit for Contract No. 1723-002-11 at 3,041,000.00 (including contingencies and GST); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1723-002-11.

#### **INTENT**

The intent of this report is to seek Council's approval to award a contract for the Intersection Improvements Package.

#### **DISCUSSION**

# Scope of Work

The construction package related to this contract consists of the installation of one new traffic signal and improvements to three existing signalized intersections at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044.

The proposed works on 152<sup>nd</sup> Street, north of 96 Avenue, includes widening the road to accommodate a bus-only lane. This will require removal of the centre median and approximately 18 Bylaw size trees (measured at least 30 centimetres diameter at breast height).

### **Invitation to Tender Results**

Tenders for the subject contract were opened on October 4, 2023 with the following results:

The Engineer's (McElhanney Ltd.) pre-tender estimate was \$3,567,000 (including GST).

#### **Evaluation**

The submissions were reviewed for accuracy and completeness. There were two arithmetic errors that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond and were signed on the Tender Form.

The low bidder, Crown Contracting Limited, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond and has agreed to complete the work within 100 working days, as stipulated in the contract. Crown Contracting Limited's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Crown Contracting Limited be awarded Contract No. 1723-002-11.

# **Project Schedule**

The contract work is expected to start in November 2023 and be completed by April 2024.


# **FUNDING**
