SUBJECT: Award of Contract No. 4821-001-11

Sanitary and Drainage Utility Improvements Package

#### RECOMMENDATIONS

The Engineering Department recommends that Council:

- Award Contract No. 4821-001-11 to Cancon Construction Ltd. in the amount of \$7,509,574.80 (including GST), for the Sanitary and Drainage Utility Improvements Package;
- 2. Set the expenditure authorization limit for Contract No. 4821-001-11 at \$8,260,000.00 (including GST) and contingency; and
- 3. Authorize the General Manager, Engineering to execute Contract No. 4821-001-11.

## **INTENT**

The intent of this Corporate Report is to seek Council's approval to award a contract for the Sanitary and Drainage Utility Improvements Package.

#### **DISCUSSION**

## **Scope of Work**

The construction package related to this contract consists of replacing aging and undersized infrastructure located at various locations as listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044.

### **Invitation to Tender Results**

An Invitation to Tender followed the City's Purchasing Bylaw and was publicly posted on the BC Bid and City of Surrey websites. Tenders for the subject contract were opened on October 26, 2023 with the following results:

The Engineer's (ISL Engineering and Land Services Ltd.) pre-tender estimate was \$7,402,786 (including GST).

### **Evaluation**

The submissions were reviewed for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed on the Tender Form.

The low bidder, Cancon Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 220 working days, as stipulated in the contract. Cancon Construction Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Cancon Construction Ltd. be awarded Contract No. 4821-001-11.

## **Project Schedule**

The Contract work is expected to start in December 2023, and be completed by fall of 2024.


Funding for this Contract is available in the approved 2023 and 2024 Utilities Budget.
